## MEMORANDUM OF UNDERSTANDING

BETWEEN

This Memorandum of Understanding (MoU) is made on 18.02.25 between Balagarh Bijoy Krishna Mahavidyalaya and Purash-Kanpur Haridas Nandi Mahavidyalaya for mutual cooperation affirming the spirit of an understanding based on mutual respect and faith, and pledge to work together in pursuit of Quality Higher Education. This document establishes the guiding terms and principles of collaboration between the two organizations:

Balagarh Bijoy Krishna Mahavidyalaya, UGC approved NAAC Accredited Government of West Bengal aided College affiliated to the University of Burdwan, situated at Balagarh, Hooghly -712501, West Bengal.

And

Purash-Kanpur Haridas Nandi Mahavidyalaya, UGC approved NAAC Accredited Government of West Bengal aided College affiliated to the University of Calcutta, situated at Kanpur, Howrah - 711410.

## PURPOSE OF MOU

In particular, this MOU is intended to

1. Facilitate teaching and learning through Faculty exchange and Student exchange.
2. Organizing various seminars, workshops and other Faculty development programmes through collaboration.
3. Collaborating on Quality initiatives
4. Cultural Exchange

## TERM AND EXPIRATION OF THE AGREEMENT

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of **Five years**. HOWEVER, either of the college would have the liberty to exit the agreement - citing reasons for so if the linkage becomes untenable for any reason whatsoever. After these **Five years** it will be automatically extended for same period, unless one of the Parties expresses an intention (by written notification) to cancel the agreement at least 90 days before the expiry date. The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination or expiration, unless otherwise agreed upon between the Parties.

There will be no financial involvement by either of the parties.

Any additions, changes, or deletions to this document must be approved by the representatives of both Parties. All notices shall be in writing and shall be directed to these representatives.
