I. Legal Frameworks of Both the Organizations:

Purash Kanpur Haridas Nandi Mahavidyalaya, established in 1966, a State Government-aided and affiliated college of the University of Calcutta, having its campus at Vill & PO- Purash Kanpur, Howrah, PIN- 711410, West Bengal, India, represented by its Teacher-in-Charge, hereinafter referred to as the **FIRST PARTY** (which term or expression shall, unless excluded by or repugnant to the context, be deemed to mean and include its successor in office, representatives, administrators, and assignees) is included under Section 2(f) & 12(B) of the UGC Act, 1956, and has rapidly emerged as one of the most promising educational institutions in Howrah, West Bengal with a strong focus on the dissemination of knowledge, offering Undergraduate Courses in honours and general Courses for the B.A., B.Sc. and B.Com streams.

Panchla Mahavidyalaya, an institute of potential in the fields of higher education of the district offering U.G. courses under B.A., B.Sc. and B.Com., founded in 2010, a state government-aided college and affiliated to the University of Calcutta, established its campus at Raghudevnpur, Uluberia, Howrah, PIN – 711322, West Bengal, India, represented by its Principal, recognized by the UGC under Section 2(f) and 12(b), is hereinafter referred to as the **SECOND PARTY** (which term or expression shall, unless excluded by or repugnant to the context, be deemed to mean and include its successor in office, representatives, administrators, and assignees).

I. Purpose of the Agreement:

Both the Parties are pleased to enter into an agreement to establish ties of academic cooperation in order to contribute to the achievement of their overall goals as institutions through the following, but not limited to:

1. Faculty exchange programmes
2. Student exchange programmes
3. Collaborative research projects
4. Joint field trips
5. Collaborative training workshops for faculty, staff, and students

6. Joint academic publications
7. Joint skill development courses
8. Joint add-on courses.
9. Joint career consultancy and placement drive
10. Co-hosting and collaborative participation in conferences, seminars, and symposiums
11. Social extension activities and cultural programmes
12. Collaborative library outreach activities
13. Any other academic activity that is mutually agreed upon and is beneficial to both the parties

II. Execution of the Agreement:

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both parties, will be attached as annexures to this agreement.

The specific sub-agreements between both Parties will specify their objectives, conditions and ways of execution, financial support, the period the sub-agreement will be in effect, and administrative responsibility within each institution.

III. Term and Expiration of the Agreement:

It is understood that this agreement will come into effect after being signed by both parties and will be established for a period of five years. After these five years, it will be mutually extended for the same period, unless one of the parties expresses an intention (by written notification) to cancel the agreement at least 90 days before the expiry date.

The amendment, termination, and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment,

Any additions, changes, or deletions to this document must be approved by the representatives of both parties. All notices shall be in writing and shall be directed to these representatives.

IV. Non-exclusivity:

This Agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third parties.

V. Special Provisions:

1. Each party will take approval from the other party in writing prior to using the later's name and logo for the activities hereunder on a case-by-case basis.
2. All parties hereto shall do their utmost to ensure the smooth and efficient implementation of the programmes.
3. The parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MoU or any subsequent associated agreement informally.
4. Neither party can misuse this MoU by involving the name of the other without the written consent of the other party.
5. Involvement of funds, if required under this Memorandum of Understanding, will be subjected to approval of relevant authority/authorities.

VII. Disputes:

If any disputes arise in respect to the MoU, both organizations will discuss and settle the matter mutually and amicably.
